PRIVACY POLICY

This privacy policy (the "Privacy Policy") applies to information collected by the Louise Nevelson Foundation (the "Foundation") through or in connection with the operation of this website (the "Site").  publish your submission on the web, in print, or otherwise. We will not disseminate other personally
 identifiable information publicly without first obtaining your permission to do so, except as otherwise
 specified in this Privacy Policy.

B. Automatically generated Information

Automatically generated information does not contain specific details about the identity of the person who provided it. Examples of automatically generated information include Internet protocol (IP) addresses and information collected via cookies (described below). When you visit and use the Site, we may in our discretion automatically gather this information. We may use this information in the aggregate to monitor the Site and to improve the Site's offerings.
